In order for our clinic to operate in a smooth and efficient manner, we have phone consultation policies and systems in place. We encourage you to read the details of this document carefully and initial each section. If you have any questions or concerns, please do not hesitate to speak with us on the matter. By law, Dr. Gurevich may not diagnose or treat your condition without seeing you in-person first and performing a physical exam at least yearly. Specifically, by phone she cannot order tests or prescriptions for you, diagnose you with any medical condition, or act as your physician. Your primary care physician and/or other doctors should always be regarded as a primary source of information about diagnosis, treatment, prescription drugs, and medical conditions.

Phone consultation appointments reserve only the specific time period scheduled with Dr. Gurevich. If you believe time outside of your appointment window will be needed to review pertinent information, consider scheduling more time or an in-person office visit. Dr. Gurevich will review any documents during your phone consultation.

_____ Payment for all consultations, telephone calls, and medicinal items are due at the time of service. **For an hour visit the cost is \$400 due at time of visit.** We accept debit and credit cards only. Following the visit you will be called by one of the staff at Kwan Yin Healing Arts Center and they will take your credit card over the phone and run it on site. We do not keep any credit cards on file.

_____ Phone consultations are offered for 1/2 hr or 1 hr sessions. The initial appointment is always an hour and follow ups are usually 30 minutes unless more time is needed.
